## Work Safely - Call Before You Dig or Cross

Landowners and contractors are reminded to CALL BEFORE YOU DIG when developing plans for work on the pipeline or within 30 meters of the pipeline right-of-way. Pipeline route markers indicate the general area of the pipeline, rather than its exact location.

Calling before you dig or cross isn't just a courtesy. It's actually a requirement of Brunswick Pipeline's regulator, the National Energy Board (NEB). Unauthorized activity around or near a pipeline may be subject to fines imposed by the NEB.
