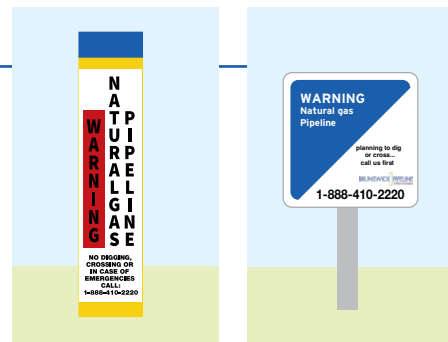

CLICK OR CALL BEFORE YOU DIG

If you are a landowner or contractor and have plans to do any construction on or near our pipeline **Right-of-Way (ROW), you are reminded to call 1-888-410-2220 or to go to www.clickbeforeyoudig.com** at least 3 days in advance of conducting any activity within 30 meters (100 feet) of the Brunswick Pipeline. As the Brunswick Pipeline is buried below ground, pipeline signs are installed above ground to indicate the general location of the pipeline. Further, Emera New Brunswick does not approve of the use of the pipeline ROW as a vehicular trail; this applies to Quads, ATVs, Jeeps, and other types of vehicles as they can do damage to the pipeline. If you find yourself on the ROW while using an off-road vehicle, please exit at a designated pipeline crossing point as soon as it is safe to do so.



Obtaining Emera New Brunswick's approval prior to beginning ground disturbance activities in the vicinity of our pipeline is not just a courtesy - it is a requirement of the Canada Energy Regulator (CER). The CER may impose fines on individuals or companies for unauthorized activities near a pipeline. For more information on these regulations, please visit the **CER website at www.cer-rec.gc.ca**
